

Equipment Case Study





CORE FY 2021-22 Background

- CORE released \$125 M on July 18, 2022, to nine equipment categories
- No one category may receive more than 20 percent of total CORE voucher funding within the first six months
- Voucher requests submittals closed on January 18, 2023



Small Business and Disadvantaged and Low Income-Community Deployments

- To support CARBs goal to provide more equitable investments
 - CORE provides additional funding for DACs/LICs and small businesses (who typically do not purchase "new" equipment)

	Amount Funded	Quantity Funded
Small Business	\$9.77 M (8 percent)	171 (15 percent)
DACs/LICs	\$105.37 (84 percent)	868 (75 percent)

FY 22-23	\$71.88 M
Total	\$80.56 M

• FY 21-22 Implementation Manual section G.4. states "If funding caps for equipment categories are lifted, projects deployed in disadvantaged/low-income communities and/or that are operated by a small business will be prioritized to receive funding. However, there is no guarantee that a voucher application on a contingency list will receive funding, and CARB reserves the right to cancel a contingency list."



Contingency List Prioritization Procedure

- All equipment categories other than terminal tractors will be funded first
- Voucher prioritization will be implemented for terminal tractors
 - Priority One small businesses <u>and</u> equipment location in a disadvantaged/low-income community, by timestamp
 - Priority Two small businesses <u>or</u> equipment location in a disadvantaged/low-income community, by timestamp
 - Priority Three All other voucher requests, by timestamp
